DECLARATION OF CONFORMITY ed. 1/2025

As the supplier of the product: EPDM MULCH GRANULES COLOR

The supplier hereby declares that all products (goods) delivered after the date of signing this Declaration (hereinafter referred to as "Products") will always be fully compliant with the requirements of the regulations listed below (hereinafter referred to as "Product Compliance Regulations").

- I. The supplier declares that the material composition of the delivered product meets the following criteria:
 - a) EPDM granules are a vulcanized rubber compound consisting of EPDM synthetic rubber, chalk, kaolin, softeners/plasticizers, colorants, and additives enabling vulcanization. All raw materials are subject to ongoing supervision and control.
All components are physically bound in the polymer and do not pose a hazard under the recommended processing conditions and when used as intended.
 - b) SVHC compliance with the candidate list for Annex XIV of the REACH Regulation.
European Union Regulation (EC) No. 1907/2006 REACH: Registration, Evaluation, Authorization, and Restriction of Chemical Substances (Candidate List of Substances of Very High Concern for Authorization (published in accordance with Article 59(10) of the REACH Regulation):

It is declared that no chemical substances from the current candidate list of the European Chemicals Agency (ECHA) published on January 17, 2023, are intentionally added in a concentration greater than 0.1% by weight to the product covered by the declaration, which is intended to be released under normal or reasonably foreseeable conditions of use. It should be noted that trace amounts may be present due to contamination from raw material sources over which Unirubber Sp. z o.o. has no influence.

Based on the chemical composition declared by Unirubber Sp. z o.o. (*Appendix "Chemical composition of MULCH EPDM Color"*).

- c) The product is not classified as hazardous to the aquatic environment.
- d) The product meets hygiene requirements, provided that the conditions set out in the hygiene certificate (Document B.BK.60111.0333.24, valid until June 10, 2029) are met.

- e) The product is classified as compliant with the requirements of PN-EN 71-3:2019-07 "Safety of toys - Part 3: Migration of certain elements" (*Document 83/DLS/2024*).
- f) The product meets the requirements for the washability of inorganic constituents, including DOC, zinc, cadmium, lead, nickel, chromium, arsenic, antimony, mercury, chlorides (Cl^-), fluorides (F^-), sulfates (SO_4^{2-}), naphthalene, phenanthrene, anthracene, fluoranthene, chrysene, benzo(a)anthracene, benzo(b)fluoranthene, benzo(k)fluoranthene, benzo(a)pyrene, benzo(ghi)perylene, indeno(1,2,3-cd)pyrene, benzene, toluene, ethylbenzene, o,m,p-xylenes (*Document 732/2024*).

g) Compliance with permissible WWA values

Based on test reports obtained from an accredited external laboratory, it is certified that the product covered by this declaration does not contain PAHs at levels exceeding the applicable standards (*Document 84/DLS/2024*).

Substances with restricted use and maximum concentration values tolerated in materials:

Benzo(a)pyrene $\leq 0.1\%$ by weight
Benzo(e)pyrene $< 0.1\%$ by weight
Benzo(a)anthracene $< 0.1\%$ by weight
Chrysene $< 0.1\%$ by weight
Benzo(b)fluoranthene $< 0.1\%$ by weight
Benzo(j)fluoranthene $< 0.1\%$ by weight
Benzo(k)fluoranthene $< 0.1\%$ by weight
Dibenzo(a,h)anthracene $< 0.1\%$ by weight

In summary, based on the available test reports and certificates, compliance with European Commission Regulation (EU) 2021/1199 amending Annex XVII to Regulation (EC) No 1907/2006 of the European Parliament and of the Council on the registration, evaluation, authorization, and restriction of chemicals with regard to polycyclic aromatic hydrocarbons (PAHs) in granules or granule-containing binders for use as infill material in artificial turf and as bulk material for playgrounds and sports fields.

II. Other

Declares that if the supplied product does not comply with the exemptions listed in point I. regarding the content of monitored substances, the content of monitored substances will be highlighted in the safety data sheet or other document containing information on the content and classification or other hazard characteristics of monitored substances in the product.

Declares that the Manufacturer is aware of the obligation to provide the supply chain with the information necessary to comply with the REACH Regulation, the CLP Regulation

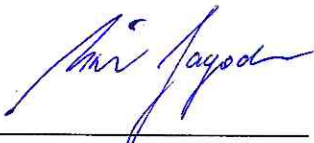
Declares that the products supplied are accompanied by the mandatory information on the material composition of substances, mixtures, and articles used to manufacture the products.
