The Supplier hereby declares that all products (goods) delivered after the date of signature of this Declaration (hereinafter referred to as "Products"), will at all times fully comply with the requirements of the regulations listed below (hereinafter referred to as "Product Compliance Regulations").

I. The supplier declares that the material composition of the delivered product meets the criteria:

a) EPDM granulate is a vulcanised rubber compound consisting of EPDM-type synthetic rubber, chalk, kaolin, softeners/plasticisers, dyes and additives to enable vulcanisation. All raw materials are subject to ongoing monitoring and control.
All components are physically bound in the polymer and do not pose a risk under the recommended processing conditions and when used as intended.

b) Compliance of SVHCs on the candidate list for Annex XIV of REACH.
European Union Regulation (EC) No. 1907/2006 REACH: Registration, Evaluation, Authorisation and Restriction of Chemicals (Candidate List of Substances of Very High Concern for Authorisation (published in accordance with Article 59(10) of REACH): <https://echa.europa.eu/candidate-list-table>.

It is declared that no chemicals from the current European Chemicals Agency (ECHA) Candidate List published on 17 January 2023 in concentrations greater than 0.1% by weight are intentionally added to the product to which the declaration relates, which is intended to be released under normal or reasonable conditions of use. It is noted that trace amounts may exist due to contamination from raw material sources over which Unirubber Ltd. has no control.

Based on the chemical composition declared by Unirubber Ltd. (*Annex "Chemical composition of EPDM Virgin Colour"*).

c) The product is not classified as hazardous to the aquatic environment.

d) The product complies with hygiene requirements provided that the conditions of the hygiene certificate (Document B-BK-60211-0468/21, valid until 15.04.2025) are met.

e) The product is classified as complying with the requirements of EN 71-3:2019-07 'Safety of toys - Part 3: Migration of certain elements (*Document 58/DLS/2025*).

f) The product meets leachability requirements for inorganic constituents including DOC, zinc, cadmium, lead, nickel, chromium, arsenic, antimony, mercury, chlorides (Cl^-), fluorides (F^-), sulphates (SO_4^{2-}), naphthalene, phenanthrene, anthracene, fluoranthene, chrysene, benzo(a)anthracene, benzo(b)fluoranthene, Benzo(k)fluoranthene, benzo(a)pyrene, benzo(ghi)perylene, indeno(1,2,3-cd)pyrene, benzene, toluene, ethylbenzene, o,m,p-xylenes (*Document 6110a/2024 Rew.1*)).

g) Compliance with limit values for PAHs

On the basis of the test reports obtained in an external accredited laboratory, it is certified that the declared product does not contain PAHs at levels exceeding the applicable standards (*Document 58/DLS/2025*).

In conclusion, on the basis of the test reports and certificates held, compliance is declared with European Commission Regulation (EU) 2021/1199 amending Annex XVII of Regulation (EC) No 1907/2006 of the European Parliament and of the Council and of the Council on the Registration, Evaluation, Authorisation and Restriction of Chemicals for Polycyclic Aromatic Hydrocarbons (PAHs) in granules or mulches for use as infill material on artificial turf pitches or in bulk form on playgrounds or sports fields.

Declares that the Manufacturer is aware of the obligation to provide the supply chain with the information necessary to comply with the REACH Regulation, the CLP Regulation

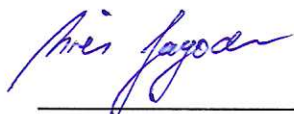
Declares that the products supplied are accompanied by the mandatory information on the material composition of the substances, mixtures and articles used in the manufacture of the products.
